All students will be assessed with the Keystone Exams. Teachers will continue to receive professional development to ensure student achievement.

The <u>FURNESS HIGH SCHOOL</u> will, with the assistance of the School District, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:
 - holding a parent meeting, September 30, 2015
