

SCHOOL DISTRICT OF PHILADELPHIA WILLIAM H. HUNTER SCHOOL PARENT INVOLVEMENT POLICY

PART I. GENERAL EXPECTATIONS

- Provide professional development by parents/caregivers for new and existing principals and other administrators on how to develop promising partnerships with parents/caregivers.
- Train new and existing staff with parental engagement duties (e.g., School Improvement Support Liaisons, School-Community Liaisons, School Community Coordinators, and Bilingual Counselor Assistants) to assist school sites in implementing parental engagement.

- Provide coordination of professional development efforts through the Office of Instruction and Leadership Support.
- Provide workshops to parents on supporting student achievement and parent engagement.
- Regional PREP parents will serve as advisors to principals and SAC members on how to address the needs of students and parents in their school's Action Plan and Title I Budget.

4. The **William H. Hunter Elementary School** will coordinate and integrate parental involvement strategies in Part A with

parental involvement strategies under the following other programs:

- *Norris Square Civic Association*
- *Head Start parents are invited to all parent meetings and school events*
- *Parent volunteer program*

5. The **William H. Hunter Elementary School** will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A programs. The school will hold monthly parent meetings to discuss PSSA assessments and results from formative assessments, PA state standards, Title 1, and the Modified Core Curriculum. In addition, a series of workshops will be offered to parents as follows:

1. *Positive discipline*
2. *How to help with homework*
3. *Literacy centers*
4. *Math games*
5. *Restorative practices*

- B. The **William H. Hunter Elementary School** will, with the assistance of the School District, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

- *Title I workshops (How to become an involved parent)*
- *Monthly parent workshops (Literacy, Assessment, Homework)*
- *School District's parental programs and workshops*
- *Family and Schools Together (FAST) program*

- C. The **William H. Hunter Elementary School** will, with the assistance of the School District, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

Conducting staff development on professional development days as well as at grade group meetings and Level 1 RtII

- D. The **William H. Hunter Elementary School** will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

Working with Norris Square Civic Association 21st century/ Beacon Program and Parent Resources Center available with brochures and staff.

- E. The **William H. Hunter Elementary School** will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including

alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

Ensuring all documentations sent home is made available in an understandable language as well as translated into Spanish for our Spanish speaking population. All parent meetings and/or workshops will be conducted in English and Spanish. All communication is in parent friendly language.
