1. Program Information

School based staff members including our School Improvement Support Liaison will provide support and expertise to our parents during our planned parent workshops.

Events will be held throughout the school year to explain and train parents on academic issues such as preparing for the PSSA assessments.

Parents are presented with documents regarding the Common Core State Standards at workshops. These documents help parents to become familiar with what their children are learning in school. Parents are also provided with books at various literacy workshops. Due to the results of the PSSA additional literacy workshops will be held for our bilingual parents.

2. Materials and Training

Provide materials and training, such as literacy training and training on how to use technology, to help parents work with their children to improve achievement.

Through Title I Parental Involvement, we will supply parents with the necessary materials to have productive workshops. We will include IT for support and use our Teacher Leader and Early Literacy Coach to provide parents with websites that are conducive to increasing literacy ability.

3. Educate Educators

Parents receive monthly newsletters in multiple languages, from the principal and special flyers or notices on an as-needed basis.

Parents are encouraged to attend Parent Meetings Meetings held on the first Wednesday of each month. At these meetings, staff members, school personnel, community, business, and university partners are scheduled to make presentations. In this manner parents are informed of important resources within the community.

6. Other Requested Activities
